**Dear Honorable Minister Hosams Abu Meri!**

The Ministry of Health of Ukraine presents its compliments to the Ministry of Health of the Republic of Latvia.

Since the night of February 24, 2022, Ukraine has been under full-scale attack by Russia. Ukraine is courageously fighting the Russian invaders, defending its homeland and protecting the Ukrainian people.

Ukrainian cities are being shelled, with rockets often hitting civilian homes and even functioning hospitals. A big part of the medical infrastructure has been destroyed. The healthcare system is in particular need of support now, as our doctors are at the frontline of the fight for the lives of Ukrainians, and our citizens need uninterrupted support, treatment and medicines.

We sincerely ask you to support the Ukrainian people in need of proper and timely medical care by considering providing us with humanitarian aid according to the Annex.

At the same time, we would like to inform you that in accordance with the Order of the Ministry of Health of Ukraine No. 474 of March 12, 2022 «Some Issues of Receiving Humanitarian and Charitable Assistance under Martial Law» (as amended by Order No. 2201 of December 26, 2022), the State Institution Public Health Center of the Ministry of Health of Ukraine (hereinafter - SI PHC) is entitled to receive medicines, medical devices, consumables, medical equipment, personal protective equipment and other goods necessary for the proper provision of health care under martial law imposed in connection with the military aggression of the Russian Federation against Ukraine. In the event of receipt of humanitarian and charitable aid, the SI PHC of the Ministry of Health of Ukraine ensures its acceptance and distribution.
