35TH MEETING OF THE ENERGY CHARTER CONFERENCE 3 December 2024

DE-RESTRICTION OF DOCUMENTS RELATED TO THE MODERNISATION AND APPLICATION OF THE POLICY ON ACCESS TO THE TRAVAUX PRÉPARATOIRES

- 1. On 6 November 2019, the Energy Charter Conference (Conference) established and mandated the Modernisation Group to conduct the negotiations on the modernisation of the Energy Charter Treaty.
- 2. In accordance with paragraph (l) of Conference decision CCDEC 201910 (Modernisation of the Energy Charter Treaty: Mandate, Procedural Issues and Timeline for Negotiations), "[a] fter conclusion of the negotiations, the summary records, audio recordings, negotiation drafts and other materials related to the negotiations will form part of the travaux préparatoires in accordance with the Manual on Data Protection".
- 3. At its 35th meeting, the Conference will be invited to:
 - (1) de-restrict the documents issued by the Conference, the Modernisation Group and the Secretariat in relation to the negotiations on the modernisation of the Energy Charter Treaty since November 2019, as listed in the **Annex**; and
 - (2) confirm the application of the policy on access to the *travaux préparatoires* as set out in Conference decision CCDEC 201624 (De-restriction of Some Documents of the Travaux Préparatoires and New Policy on Access to the Travaux Préparatoires) to these de-restricted documents.
